## Research Paper (20%)

Students are expected to prepare a research paper regarding an issue covered in the class. The assignment should be 3000-3500 words in total (%30). I encourage you to discuss your topic with me before you begin your research. You will prepare an abstract (around 200 words) and send me on the 5<sup>th</sup> week (**15.03.22**) of the course.

For late submissions, students will be assessed a penalty of 10% per each calendar day. Late submissions will not be accepted after five calendar days. Deadline can be extended only for highly exceptional cases.

## Presentation (10%)

You will present your final paper. Prepare an attention-grabbing presentation revealing your personal findings. Presentations should be 7-8 minutes (6-7 minutes plus 1-2 minute Q & A). Failure to realize the presentation will result in 0 points for this assignment. Dates: 13<sup>th</sup> and 14<sup>th</sup> weeks of class.
